General Guidelines:

- i. Interested students shall apply through the Head of the Department in the prescribed application form available on the CIFE website (www.cife.edu.in). The application shall be neatly typed, duly certified, signed and forwarded through the proper channel and can be sent (using Annexure – I for Prof. Ravindranath Krothapalli best Ph.D. Thesis Award) to the Director, CIFE, Mumbai (For address please see serial No. iii).
- ii. It is to emphasize that awards will be considered for 2021 and relevant period of reporting and consideration would be strictly followed from 01.04.2020 to 31.3.2021 for 2021, for the award listed in the table, on the basis of publication and degree/ thesis awarded between the above mentioned period.
- iii. The filled-in Application Form should be sent as a mail attachment to **the Director, ICAR-Central Institute of Fisheries Education, (Deemed University), Panch Marg, Off Yari Road, Versova, Andheri (West), Mumbai – 400 061 in soft Copy only on or before 31.08.2021 in mail ID (endowaward@cife.edu.in).**
- iv. Looking into Covid-19 situation in Mumbai, the award shall be given on a suitable date, which shall be intimated well in advance.

- v. Award Endowment Fund will contribute towards the travelling expenses of student selected for the award at a rate corresponding to the amount of 2nd Class Mail railway fare by the shortest route to the place from the Railway Station nearest to the normal place of residence of the student or from where he/she actually performs the journey, whichever, is nearer to the CIFE, Mumbai, and back to the same station or the amount of Railway fare actually incurred by the student whichever is less provided he/she fulfill all the conditions.
- vi. Each candidate will be judged based on the originality and/or the applied value of the research work/ investigations as revealed in the documents submitted by him/her. In all matters relating to the award, the decision of the ICAR-Central Institute of Fisheries Education, Mumbai shall be final, and no correspondence on this account will be entertained.
