In order to recognize the significant contributions of Fisheries Scientist in the country, the following award is being announced for the year 2017. The award will be given to any Young Scientist, below 40 years (as on 31.3.2017), for his/ her published work in the field of Pisciculture, Marine conservation, Ichthyology etc. on the basis of publications, projects handled, teaching courses, technology developed, conservation methods developed or any applied research initiated or demonstrated related to fisheries from CIFE, other Fisheries Institutes/ Universities of India, engaged in fisheries activities, for *original work* done during the preceding five years. This award is called “**Dr. C.V. Kulkarni Best Young Scientist Award**”, is being announced, as instituted for the first time, for the year 2017. The evaluation pattern, process and the application format have been thoroughly revised so as to bring more objectivity, transparency, competitiveness and professionalism in the selection process. This Award is meant to reward talent and promote high quality research in Fisheries Sciences including basic & applied research.

**General Guidelines:**

- i. Interested scientist shall apply through the Head of the Department in the prescribed application form available on the CIFE website ([www.cife.edu.in](http://www.cife.edu.in)). The application shall be neatly typed, duly certified, signed and forwarded through proper channel and can be sent (using Annexure – I) to the Director, CIFE, Mumbai.
- ii. The award will be considered for 2017 and relevant period of reporting and consideration for the award would be from 01.04.2016 to 31.3.2017.
- iii. The filled in Application Form by the Young Scientists be sent as a mail attachment to the **Director, ICAR - Central Institute of Fisheries Education, (Deemed University), Panch Marg, Off Yari Road, Versova, Andheri (West), Mumbai – 400 061, in soft Copy only, on or before 06.08.2020 in his mail ID ([gopalkrishna@cife.edu.in](mailto:gopalkrishna@cife.edu.in)).**

- iv. Looking into Covid-19 situation in Mumbai, the award shall be given in a memorial lecture day-cum-function, to be organized on a suitable date, on Dr. C.V. Kulkarni at ICAR - Central Institute of Fisheries Education, (Deemed to be University), Panch Marg, Off Yari Road, Versova, Andheri (West), Mumbai – 400 061.
- v. Central Institute of Fisheries Education, Mumbai will contribute towards the travelling expenses of Scientist/ Farmer selected for the award at a rate corresponding to the amount of AC 3-Tier railway fare by the shortest route to the place from the Railway Station nearest to the normal place of residence of the Scientist/ Farmer or from where he/she actually performs the journey, whichever, is nearer to the CIFE, Mumbai, and back to the same station or the amount of Railway fare actually incurred by the Scientist whichever is less provided he/she fulfill all the conditions.
