PAYMENT OF RMA ARREARS TO CG VETERANS RETIRED/RELEASED W.E.F. 01 JUL 2017

Dear Veteran,

- 1. Ration Money Allowance to Coast Guard Officers & Enrolled Personnel has been approved by the GoI, MoD w.e.f. 01 Jul 2017. Ration Money Allowance is allowed to all Coast Guard Officers and Enrolled Personnel of Indian Coast Guard at par with Indian Navy. RMA shall be allowed with effect from 01 Jul 2017 till issue of the orders of Free Ration/ Ration-in-Kind (i.e. 06 Oct 2020).
- 2. **RMA Rates**. The prevailing rates of RMA in accordance with GOI, MoD letter No. PC-12045/Q/ST6/(Common Ration/ 1411/D(QS)/2019 dated 04 Apr 19 as follows:-

- 3. **Eligibility**. The eligibility conditions for RMA are as follows: -
 - (a) RMA is entitled to all officers and enrolled personnel including those posted in ashore appointments in lieu of Ration w.e.f. 01 Jul 17.
 - (b) RMA is entitled to all Coast Guard personnel while posted onboard ships and ashore appointments in lieu of ration during following contingencies: -
 - (i) During leave where pay is admissible including Special Casual Leave.
 - (ii) Joining Time including leave while on permanent posting.
 - (iii) Whilst on temporary duty but not claiming daily food charges.
- 4. In view of the aforesaid, you are requested to forward following to your last unit for verification, countersignature and onward submission to CG Veteran Cell: -
 - (a) Prescribed format for claiming arrears of RMA (copy attached).
 - (b) A self certificate by the veteran claiming arrears of RMA is to be duly countersigned by the respective Commanding Officer of the last unit for the period from 01 Jul 17 to till date of retirement/ release. Format of self certificate is attached.
