Incomplete quotation will not be accepted.**

Note:

1. FOR destination IIIT-Allahabad, Deoghat Jhalwa, Prayagraj. (If Required)
2. Quoted rate should be valid at least for 45 days from the last date of submission of tender.

3. **All the compound target must be expressed in terms of their molecular composition (Molecular weight).**
4. **All Target must be supported by backing plates.**
5. Tenderer should submit GSTIN registration copy with quotation.
6. It is mandatory to sign & stamp on all the papers of the tender/ enquiry letter.
7. Tenderers are desired to quote all the items as mentioned above, failing which quotation will not be considered.
8. Enquiry/tender must be quoted in prescribed format on the letter head of the firm/vendor, otherwise quotation shall be rejected outright.
9. Supply should be completed within 04 weeks from the receipt of the work order, If the work delayed beyond the stipulated time of completion penalty of 1% per week or part thereof of total cost shall be imposed at the discretion of Competent Authority. The penalty may be upto 10% of the total accepted bid value.
10. If it is found that items are fake or of sub-standard quality and not conforming to the required specifications, the firm, will have to replace the fake/sub-standard items with genuine ones immediately. Additionally, they will also be liable to be blacklisted.
11. Conditional quotations are liable to be rejected. In the event of acceptance, Director's decision shall be final and binding on both the parties. The rates should be quoted as per our required specifications. The quotation which is not as per our required specifications will not be considered.
12. The right to accept or reject any tender/quotation, partially or wholly, including lowest quotation without assigning any reason whatsoever thereof or incurring any liability thereby is reserved with the Director, IIIT, Allahabad. The decision of the Director, with regard to enforcement of these terms and conditions herein contained, as a result of breach of these conditions by successful Tenderers, shall be final and the Director, shall not be liable for any damage/liability put forth by the Tenderers at any stage of the transaction arising out of the enforcement of any or all herein contained terms and conditions.

15. If the supplier/Contractor/Agency fails to execute the contract and informs IIITA about its inability to execute the order and non-compliance of the contract, the

supplier/Contractor/Agency shall be liable for debarred for a period of 02 years and bid security will be forfeited.
