In accordance with the provisions of revised Career Advancement Scheme for ARS Scientists introduced vide Council's letter No. 1(1)/2009-Per.IV dated 06.03.2009 effective from 01.01.2009 and Revised Performance Evaluation/Score Card for upward movements/promotions under revised CAS notified vide Council's letter No. 9(1)2010-Per.IV dated 04.11.2011 and clarifications of even number dated 12.12.2011 and No.9(1)/2012-Per.IV dated 25.04.2012 and OM F.No.9(1)/2010-Per.IV dated 24.3.2021, the cases of Scientists who are **due upto 31.12.2024** for Career Advancement Scientist in Research Pay Level 10 (Rs. 57,700-1,82,400) to Scientist in Research Pay Level 11(Rs. 68,900-2,05,500), Scientist in Research Pay Level 11(Rs. 68,900-2,05,500) to Sr. Scientist in Research Pay Level 12 (Rs.79,800-2,11,500), Sr. Scientist in Research Pay Level 12 (Rs.79,800-2,11,500) to Sr. Scientist in Research Pay Level 13A (Rs.1,31,400- 2,17,100) are to be considered at the Institute level by the Selection Committee as per revised Career Advancement Scheme for ARS Scientist.

The Scientists who were considered earlier under the revised CAS, but not recommended for assessment/promotion, may also indicate the period of earlier assessment in the proposal.
